About the project

Under the Justice Programme 2021-2027, ERA is implementing a new training project for judges and prosecutors from Estonia, Latvia and Lithuania in partnership with the Office of the Prosecutor General in Estonia, the Latvian Judicial Training Centre, the National Courts Administration in Lithuania, and with the support of the Supreme Court of Estonia, the Prosecution Office of the Republic of Latvia and the Prosecutor General's Office of the Republic of Lithuania.

The aim of this project co-funded by the European Union is to deepen the knowledge of Baltic judges and prosecutors on EU law, to improve their skills in the application of EU law, enhance mutual trust among members of their judiciaries, and pave the way for the creation of a pool of experts who can deliver training at national level and come together in a network of EU court coordinators.

The training project consists of a series of regional cross-professional and trans-national seminars, a series of in-depth webinars on topics focusing on digital skills and cross-border cooperation, and a study visit in Trier and Luxembourg.

Detailed Objectives

- To train ca. 165 judges and prosecutors by organising 3 one-and-a-half-day transnational, cross-professional interactive and practical legal training courses focusing on the rule of law, the preliminary reference procedure and the Charter of Fundamental Rights
- To enhance the digital skills of ca. 150 judges and prosecutors with a special focus on cross-border procedures and the taking of evidence by organising 5 half-day webinars
- To organise a three-and-a-half-day study visit for ca. 40 judges and prosecutors in Trier and Luxembourg
- To provide a platform for exchange of best practices, information and knowledge in a practice-oriented way, which could lead to creating a network of EU experts among the Baltic judiciaries



Methodology

The content of the seminars will be carefully adapted to the level of knowledge of an advanced group of participants. Judges' and prosecutors' particular needs will be taken into account, so each training session will consist of a mixture of advanced-level introductory presentations and a practice-oriented session. The practical session will be either cases studies or exchange of best practice and experience from the everyday work of a national judge and prosecutor.

Content

Advanced legal training courses will cover the following topics:

- Rule of law in the EU
- Preliminary ruling procedure before the CJEU
- The Charter of Fundamental Rights of the EU

Webinars will cover:

- Legislative databases and search tools: Curia, HUDOC, ECHR-KS, EUR-Lex
- FRA's online tools: EU Fundamental Rights Information System - EFRIS, Criminal Detention Database, Case-law Database, Charterpedia and Charter e-guidance
- European Investigation Order (EIO) and e-CODEX
- E-evidence
- ECRIS

The study visit will consist of:

- debates on key issues for judiciary in the EU
- exchange of best practice among judiciary
- meeting with CJEU judges and European Public Prosecutors
- sessions on preliminary ruling procedure before the CJEU in practice
- sessions on cooperation with the EPPO in practice
- meeting with court coordinators in European law from selected Members States
- workshops on training methodology
