Objective

This webinar, which forms a part of a larger project on a Baltic network of EU law experts, focuses on the EU Agency for Fundamental Rights' (FRA's) search tools and databases that can assist members of the judiciary in their daily work and with cross-border cases. It will explain online tools that can assist legal practitioners in mutual legal assistance instrument decisions, such as EFRIS and the Criminal Detention Database. It will also focus on FRA's tools to assist with understanding the EU Charter of Fundamental Rights, such as the Charterpedia. The Data Explorer tool, which provides quick access to data compiled by FRA on various topics such as asylum, migration and borders, justice, victims' rights and judicial cooperation and equality, non-discrimination and racism, will also be explained, as will the Guardians of Unaccompanied Minors training and learning platform. A step-by-step guide will be provided on how to effectively use these digital tools, with examples provided on how to use them to search.
